Fulfilling the Great Expectations

"...most states spend approximately half of their annual budget on public education. Therefore, it is fair for Americans to expect a high return on the investment they are making."

Public education is one of the most debated topics you can find in print. Did you know that you will find over 1.3 billion references to "public education" on Google? I suppose this should not be surprising, since most states spend approximately half of their annual budget on public education. Therefore, it is fair for Americans to expect a high return on the investment they are making. This fact, coupled with the reality that most adults attended a public school during their "schooling years," creates an environment in which most people have opinions about an abundance

The Phi Delta Kappa / Gallup "Poll of the Public's Attitudes Toward the Public Schools" has been conducted annually for the last 49 years. It has become the most trusted and most referenced source of public opinion data regarding K-12 education, because of its rigor, depth, and commitment to capturing a large range of voices and viewpoints.

of public educational matters.

I found many of the results from the last year's poll to be quite interesting. I've noted a few of these findings to set the foundation for some of my thoughts regarding our

local school corporation in Greenfield-Central.

- When determining the main goal of public education, 49% of Americans suggest academic preparation is most important, whereas 26% indicate preparation for work and 25% state that citizenship should be the mission.
- 82% of Americans support job or career skills classes being required, even if this means less time in academic classes.
- 82% indicated that it is highly important for schools to help students develop interpersonal skills (cooperation, respect, persistence, and problem solving).
- 80% of Americans noted that Technology and Engineering classes are an extremely important element for school quality.
- 76% determined that advanced class opportunities are a highly important indicator of school quality.
- 70% said it is extremely important for schools to offer a wide variety of extracurricular activities.
- 71% mentioned that it is extremely important for schools to offer a wide variety of art and music classes.

This is just the tip of the proverbial iceberg regarding what you will find in the survey results, but I think it begins to capture the essence of the expectations that are placed on today's 21st century schools. The American people want (and expect) public schools to be all things to all students. I am really not trying to make a sarcastic point. There is a reality that parents of school-aged children want schools to offer a cornucopia of options for the wide variety of students that are served. As a result, most 21st century public school corporations work tirelessly to accomplish this end for their constituents.

I have had the great fortune of working in the Greenfield-Central Schools for more than 18 years now. I believe that I have a solid working knowledge of where we have been, where we currently are, and where we intend to go. This being stated, I can say that I am extremely proud of our school and community for the collective response we have shared in this high calling of preparing our youth for life beyond the walls of our K-12 institution.

Resources for Families

School Supplies

The **BackPack Attack** program, coordinated by the United Way of Hancock County, will provide school supplies to students in need, grades K-8. These supplies, which may not include everything on your child's supply list, *will be available at registration time* in each building and throughout the year as needed. The **Salvation Army** will provide paper and pencils for students in need at Greenfield-Central High School.

BackSack Program

In partnership with Gleaners Food Bank, students in grades K-6 will have the opportunity to participate in the **BackSack program**. BackSacks, which are distributed on Fridays to students in need, contain kid-friendly meals and snacks for the weekend. Please contact the school social worker or school counselor at your child's school for more information about these programs or any other student or family need that may exist.

School Based Food Pantry

Students in grades 7-12 have access to school based food pantries, both at Greenfield Central Junior High School and Greenfield-Central High School. Students and/or families should contact the school counselor in either building for information.

Student Services Staff

Greenfield-Central is proud to have a school social worker or school counselor in each of its buildings. Members of this specialized team are available to help students and families with social, emotional, behavioral, and environmental needs that may exist.

Inclement Weather

For information about weather-related school delays and closings tune in first to the school corporation website, **www.gscs. k12.in.us**, or our radio station, **WRGF** (89.7 FM). You may also check the following stations after 6:00 A.M. – Radio: WRGF or Television: WISH-TV, WRTV, and WTHR.

The school instant alert system provides updates on delays or school closings. Families can add/update emergency information during student registration. If there is a need to dismiss students early from school due to inclement weather, parents should ensure students understand their family's early release plan. Please do not call the school officials' home. Administrators will be conferencing to gather facts and make sound decisions about school closings.

MEDICATIONS

School personnel will only administer medications needed to maintain a child in school and which must be given during school hours. Once a day medication and first morning doses are to be given at home. The parent is to provide the medication and any supplies necessary to administer the medication. Please bring medication to your school's health assistant during open registration times prior to the first day of school. You can visit the Health Services tab of the corporation website for further details regarding medication guidelines and forms.

1:1 eLearning Days Guidance for Parents and Students

eLearning Days may be used on a day when school is cancelled, as a planned day, or as a make-up day when a day of school was missed due to inclement weather. The school corporation may also use an eLearning Day for professional development, or widespread illness.

How to Plan -

- Schools will practice mock eLearning Days to prepare students for eLearning Days at home.
- Students will have regular assigned classwork on eLearning Days, and their teachers will be available electronically.
- Students will still be required to complete

and submit all assignments, as well as communicate with their teacher during the virtual eLearning days.

 Most common eLearning technology questions and answers will be available online.

How it Works -

Students with internet connectivity challenges, will be encouraged to download
their assignment bundle during school so
they can work on their device offline at
home during the eLearning Day. This will
allow the student to continue to progress
academically, and upload their work next
time they are at school.

- Free public wi-fi locations, will be offered as another option.
- Teachers will be expected to make contact with students, track virtual attendance, and be available to students during virtual office hours.
- During eLearning days, technology staff will be answering technology-related issues through email support@gcsc.k12.in.us and the phone hotline 317.477.4111.
- These options are only available during eLearning Days specifically for eLearning support.

GCSF Announces "Just Imagine" Scholarship

The Greenfield Central School Foundation (GCSF) is pleased to announce the establishment of the Just Imagine Shirley Gibbs Scholarship for graduating seniors from Greenfield-Central High School. The Foundation was the grateful recipient of an estate gift from Shirley Gibbs for the purpose of providing scholarships to G-CHS students.

The Just Imagine scholarship is meant for students in need of financial assistance whose parents or guardians do not have the financial capacity to pay for their education. Selection will be based primarily on financial need, but scholastic ability and achievement may also be considered. Graduating seniors who are qualified and want to pursue higher education are eligible. This scholarship may be used for tuition, room and board, books, school supplies, and medical expenses not otherwise covered. Beginning in 2019, GCSF will be offering two \$2,000 scholarships that will be renewable for up to 4 years. Two new scholarships will be offered annually.

thing, and few schools can say that they offer every class, activity, club or event that is requested within their respective community. Although this is true, I believe that Greenfield-Central offers an extremely comprehensive curriculum for our students in all grades; one that meets most of the criteria that I highlighted from the PDK/Gallup survey. I thought it would be helpful to briefly mention a few examples from each of these categories addressed in the survey.

Specific to job skills and interpersonal skills, Greenfield-Central High School instituted the Governor's Work Ethic Certificate program this last year. Skills such as persistence, respectfulness, initiative, dependability, efficiency, discipline and community service are all components of this program. Along these same lines, our Jobs for America's Graduates (JAG) program has assisted a number of our students over the past five years, helping them build a portfolio to support their competencies in these very skills. Through these two programs, we have dramatically increased our focus on the soft skills that our local employers are coveting to see in our graduates.

Regarding Technology and Engineering classes, G-C has been a leader in the Project Lead the Way curriculum for more than a decade. Beyond the numerous classes we offer to our students in these programs, we also have received many accolades in VEX Robotics, the NASA Rover competition and the SuperMileage competitions that all require high levels of STEM competencies to be successful. To further highlight the technology expectations we have placed on all students, G-C is equipping our students (K-12) with a digital device to support technology integration efforts in all classrooms. We are committed to extending learning opportunities for our students with a modern curriculum that allows for more personalization and more engagement through the use of technology.

Americans expect to see advanced course offerings in their schools. I am pleased to note that our junior high students earned almost 700 high school credits last year, and our seniors in the class of 2018 earned credit in 821 college courses in that same time frame. (More than 52% of last year's seniors earned college credits while attending high school.) This is possible because G-CHS has Advanced Placement (AP) and/or dual credit course offerings in 10 of our 12 departments. Our students are prepared for heightened levels of success at the secondary level, because we have a K-6 curriculum in place that is preparing our students for this advanced coursework. We are continuing our quest to encourage even more students to earn college credits and / or industry certification while attending our high school, because we want our graduates to be equipped for life beyond high school immediately after graduation.

When we take a close look at the extracurricular opportunities that Cougar students are afforded at our high school alone, I am amazed at the options that our students have. To be more specific, we offer 20 varsity sports, and we have over 40 sanctioned clubs
