The Greenfield-Central High School Driver's Education program, spring semester "Classroom" portion/course will have three classroom spring sessions and one summer school session this year: Please check below which session your student will be taking:

April 2, 4, 9, 11, 16, 18, 23, 25, and 30, May 2nd, May 7th
Classroom time: 3:30-5:30 p.m.

_____ Summer School class days (Dates and time to be announced)

The driving portion will be offered in June during regular summer school. If your student is taking other summer school classes, please indicate that on the emergency form. It is the responsibility of the student and parent or guardian to avoid schedule conflicts with summer school. Drive times scheduled for the month of June are: 7 a.m. – 10 a.m.; 10 a.m. – 1 p.m.; 1 p.m. – 4 p.m. Students who successfully complete their classroom portion of the class in the spring will be given top priority in choosing their driving time in the summer, if their fees are **paid in full**. Due to the limited number of time slots, some requests can't be honored. The above dates are subject to change pending any inclement weather. **The fee for the entire Driver's Education Program is \$365.00 and must be paid in full by May 4, 2012 before drive times can be scheduled. A \$200.00 deposit is required by March 7, 2012 before the student can start class on March 12th.**

The new Indiana Graduated Driver Licensing Law requires the student to be 15 years old before they can start any part of the Drivers Education program. The third Spring classroom starts on March 12th. You must be born on or before March 12, 1997.

Payment must accompany this contract along with the Emergency Information sheet to Mrs. Alldredge. **Checks made payable to Greenfield-Central High School.** Classroom and driving time will be offered at summer school during the month of June, for students that are unable to take the Spring Classroom.

Drive times will be available towards the end of the class time and will be assigned in the order of registration and the course fee of \$365.00 paid in full.

All students taking the classroom portion of drivers education **must by state law**, complete 30 hours of classroom instruction. There are no excused absences in Drivers Ed. All students in the driving portion of the Driver's Education program **must by state law**, complete 6 hours of drive time. If a student is absent from any of the driving sessions, he/she will **not** be able to make those up. **Tardies:** There are **no tardies** to driver's education classroom or driving sessions – if you want your license, you will be there on time, **period!**

The Driver's Education Program fee is **NON-REFUNDABLE**. If the student does not comply with attendance, habitual tardiness or discipline, or if they are withdrawn from the Driver's Education program and/or school, no refunds. Drivers Ed students will need to be 15 years old, and have their permit before they can participate in the Drivers Ed program including classroom time and drive time.
