- II. Dr. Gellert presented the 2010 Hancock Madison Shelby Educational Services (HMSES) Interlocal Agreement. The Agreement was entered on June 23, 2010, by the six members of the Interlocal: Greenfield-Central, South Madison, Mt. Vernon, Southern Hancock, Eastern Hancock, and Northwestern Shelby. After a lengthy discussion, the Board agreed that Dr. Olin needed the opportunity to build a better understanding of the operational and fiscal programs of HMSES. The Board also agreed to encourage its members to attend the HMSES board meetings, and to place this topic as an agenda item for future Greenfield-Central Regular Board meetings.
- III. Mr. Zurwell presented the recommendation for Director of Technology Greg Thompson to renew an Application Developer Stipend at \$6000 for the 2014-15 school year. After discussion, Ms. Dowling made a motion to approve the recommendation with appreciation and Mr. Menser seconded the motion. The motion was approved,
