# **Relevant Learning**

We work tirelessly to implement educational "best practices" that yield the greatest levels of student learning and growth.

Every school corporation wants to provide its students with **RELEVANT** learning experiences that prepare them for the world beyond its K-12 classrooms. Most educators would support a statement along these lines, but what does "relevant learning" truly look like? Merriam Webster defines relevant as "having significant and demonstrable bearing on the matter at hand." With that definition in mind, I assert that educational leaders are saying we want our students to have learning experiences that add value in a manner that is easily seen in (and by) our graduates.

We have used the phrase, "learning for all, all for learning" as our mission statement in Greenfield-Central for over a decade. The words are still as meaningful for our staff today as they were when we first penned them. Everything that we do as a school corporation should start and end with the concept of learning. For this reason, we regularly ask four questions in our schools that revolve around this theme of student learning.

1) Are we appropriately identifying what we want students to learn and be able to do?

- 2) Are we effectively measuring student learning in these areas?
- 3) Are we making the appropriate adjustments for students who are not learning the designated curriculum?
- 4) Are we enriching the learning opportunities for students who have already achieved mastery of the prescribed curriculum?

In G-C, our teachers are discussing and debating these thought-provoking questions every Tuesday in small groups we call Professional Learning Communities (PLCs). This setting creates an environment that is almost magical. It is truly cerebral work for our staff, and the results of the friction lead to problem solving that benefits all students. It is definitely an environment in which "iron sharpens iron."

All four of the questions listed above are important, yet I would go on record to state that the first question is the most important one for us to consider. "What do we expect students to learn and be able to do?" Are we, as a corporation, focused on the things that make education relevant for our students? We certainly do not always get this right, but most of the time I truly believe we do. For example, every time the state has changed the content standards in the last ten years, we have quickly worked to "retool the die" to ensure that our students are prepared to demonstrate the right type of learning in local and state assessments.

Beyond changing our curriculum maps to reflect the new standards, we are constantly looking at the instructional practices that we use as well. We work tirelessly to implement educational "best practices" that yield the greatest levels of student learning and growth. Within the area of instructional practices, we have made a significant shift to include personal computers for all students in grades 6-12 over the last two years. These devices were purchased to be a tool that allows teachers to provide instruction in some ways that were not possible before the digital convergence. We are striving to provide more opportunities for creativity, collaboration, and personalization in learning for our students, and we are seeing more and more evidence of these ends in the classroom as a result of this shift.

- 2. Five doses of diphtheria, tetanus & pertussis (DTaP) vaccine
- 3. Four doses of polio (IPV) vaccine
- 4. Two doses of measles, mumps & rubella (MMR) vaccine
- 5. Two doses of chickenpox (Varicella) vaccine or physician documentation of history of disease
- 6. One dose of tetanus and pertussis (Tdap or Adacel) vaccine
- 7. Two doses of meningitis (MCV4) vaccine

Clinics will be held July 17, 18, 19, 21, 24, 26, 27, 28, 31, and August 1, from 9am-3pm. On July 20 and 25, the clinic will be open from 9am-6pm. The HCHD is located at 111 American Legion Place. #### **MEDICATIONS**

School personnel will only administer medications needed to maintain a child in school and which must be given during school hours. Once a day medication and first morning doses are to be given at home. The parent is to provide the medication and any supplies necessary to administer the medication. Please bring medication to your school's health assistant during open registration times prior to the first day of school. In Greenfield-Central, we have been deliberate about the pace of change we are directing on the instructional front. We are working to create a blended learning environment (traditional and digital learning opportunities) that is relevant for the students of G-C. We want our students to be ready for whatever awaits them after graduation. For a vast majority of our graduating students, there will certainly be expectations for them to be literate and productive with digital devices, as well as being competent with more traditional means of learning and communicating.

I recently spent some time with the Greenfield-Central leadership team, and we embarked on the task of writing a theory of action for the corporation. We began our exercise with the end in

Despite the fact that the word **RELEVANT** seems to continually evolve, I believe we have taken broad strides toward our goal of creating a relevant learning experience for all students in the corporation. We will certainly continue to drive toward this objective, and I want to thank you for your partnership in this worthwhile endeavor.

#### **Grades 6-12 Athletic 2017-18 Athletic Forms**

All incoming 6-12th grade potential athletes must have **ALL** required athletic paperwork on file in their school's Athletic Office prior to conditioning/tryouts of their first sport. Pre-Participation Physicals for the 2017-2018 school year *must be dated after April 1*, 2017.

**BEGINNING APRIL 1, 2017**, visit the High School Athletic website: *http://gchs.gcsc.k12.in.us*. Click on *Athletics*, then *Cougar HQ*, then *Athletic Paperwork*, click on *IHSAA Physical 2017-2018* to download and print the 4-page IHSAA Pre-Participation Exam-2017 to take to your doctor. Please put your student's full legal name, the 2017-2018 grade level, and completely fill out pages 1 and 4. The doctor must completely fill out page two. Once completed please turn it into the appropriate athletic office.

To complete your student's on-line forms, click on the RankOne link found under the Athletics tab on the high school website. Then, using your student's PowerSchool ID number, select Electronic Participation Forms (not Login) and complete the rest of your student's required paperwork. Once you have completed all steps in these two paragraphs, your student may condition/tryout for a sport.

\*\*All 2017-2018 physicals and online forms will expire June 1, 2018 no matter when physicals were given.\*\*

Fees will be due as soon as your athlete is on the roster of the sport(s) they will be playing. Fees will be considered past due and non-participation will take place on the day of the first competition against another school, i.e. scrimmage or game.



#### **Lunch Detention for Minor Infractions**

A new type of detention will also be in effect this school year. **We are introducing Lunch Detention**. Lunch Detention will be used for minor infractions such as tardies or minor classrooms disruptions. Once students get their lunch, they will be escorted to a designated area where they will serve their detention.

#### **Drugs/Alcohol & Student Activities**

In regards to student activities, if a student is caught with **drugs/alcohol** of any form on or off school grounds, students will be removed from the club/organization. As well, if a student in a leadership position is at a party/gathering where drugs/alcohol are present, they will have 15 minutes to remove themselves from the party. As long as the student has not consumed or partaken in any drugs or alcohol, no penalty will be enforced.

On the first offense, the student will have a 25% (up to nine weeks) suspension from club/organization activities. If applicable, the student will share rehabilitation and/or community service information with the Student Activities Director. On the second offense, the student will be removed from clubs/organizations for the remainder of the current school year.
